

For and on behalf of Managing Director JKSRTC, applications are invited from the registered Load Transport contractors for their registration as empanelled vendors for transportation of left-over load carriage demand for a period of five years in the first phase (2018-22). The applications should reach to the office of General Manager Load JKSRTC by or before 15th of Nov-2018. No application/representation shall be entertained after expiry of last date of receipt. Detailed terms and conditions of the contract can be had from the office of General Manager (Load) JKSRTC M.A.Road Srinagar during the office hours or may be down-loaded from official website www.jksrtc.co.in of JKSRTC.

The Prospective bidders having the following qualifications can apply for empanelment:

1. They must be duly registered with the relevant authority of the State of Jammu and Kashmir. As the proof in support the applicant firms/companies seeking empanelment will submit the following:

Firms: Scanned copy of the Form "A" & Form "C" issued by the Registrar of Societies Jammu & Kashmir.

OR

Companies: Certificate of incorporation issued by the Registrar of Companies Jammu & Kashmir.

2. The applicant Firm/company must have a fleet of minimum 25 (twenty five) vehicles (HGVs only) registered in its own name. A list of such vehicles covered under an affidavit and Xerox copies of the Registration certificates (RCs) thereof shall be submitted.
3. The self-attested list of 100 (one hundred) vehicles (HGVs only) attached with applicant firm/company duly covered with an affidavit shall be submitted.
4. The applicant firm/company for empanelment shall submit a scanned copy of the valid Motor Transport Service License (MTSL) issued by the competent authority of the J&K State as applicable under Sec.127 (2) of the J&K Motor Vehicles rules.
5. The applicant firm/company must possess work experience of minimum 5.00 crores in the field of transportation of goods (packed in bags) in each of the last 5 (five) consecutive financial year (2013-14, 2014-15, 2015-16, 2016-17 and 2017-18) without fail. The work done experience certificate may be for single or multiple works and is to be obtained from a Central/State Govt. Deptt/undertaking/Corporation. The work done certificate duly signed by the competent authority, besides successful execution and completion of the contract.
6. The application for empanelment, on the prescribed form, must be submitted along-with necessary fee in the shape of a FDR for Rs. 50.00 (rupees fifty lac only) pledged to the FA & CAO JKSRTC. The empanelment once approved/made shall be valid for a period of 05 (five) years.
7. The CHT contractor thus registered with JKSRTC for carrying out left over demand will not be entitled to participate with any other such activities outside the corporation till they remain registered with the JKSRTC.
8. Registration fee of Rs.15000/- non-refundable by way of call deposit receipt valid at Call/Bankers cheque in favour of FA&CAO JKSRTC, payable at JK Bank RR Srinagar/Town Hall Jammu.
9. Income tax return from the last 5 (Five) years.
10. Audited balance sheet, profit & Loss account for the last five years.

11. Affidavit attested by First Class Magistrate to the effect that if during the period of contract, the contractor indulges in any activity that construes as an Act unbecoming of a law abiding citizen, the contract is liable to be terminated.
12. In case the empanelled CHT contractor/s fails to provide the demanded number of vehicles, the FDR/EMD/Security deposit of the firm shall be forfeited, besides risk and cost shall be imposed.
13. In case of any dispute between the parties viz-a-viz JKSRTC and empanelled vendor the Managing Director JKSRTC will be the sole arbitrator and his decision shall be binding upon the parties.

The applicant firms/companies having backgrounds as under shall not qualify for empanelment.

- a. Any black-listed firm/company by a Central/State Govt. Department/Undertaking/Corporation/JKSRTC in the last 05 (five) years.
- b. A firm/company any of whose Partner(s)/Director(s)/Proprietor having share in membership of any firm/company that has been black-listed by central/State Govt. Department/Undertaking/Corporation/ JKSRTC in the last 5 (five) years.
- c. Any firm/company whose EMD/Security Deposit or any part thereof has been forfeited by the Central/State Govt. Department/Undertaking/ Corporation/ JKSRTC on the basis of breach of contract/ agreement including on account of risk and cost in the last 5 (five) years.
- d. Any firm/company whose Proprietor/Partner/Director (as applicable) has been convicted by any judicial court for any Criminal breach of trust and sentenced to imprisonment for a period of three years or more.
- e. The applicant firm/company which is a Roller Flour Mill owner whether as a sole proprietorship, partnership firm or a company or an applicant firm company or proprietorship whose any partner/Director or the proprietor is a partner in any Roller Flour Mill.
